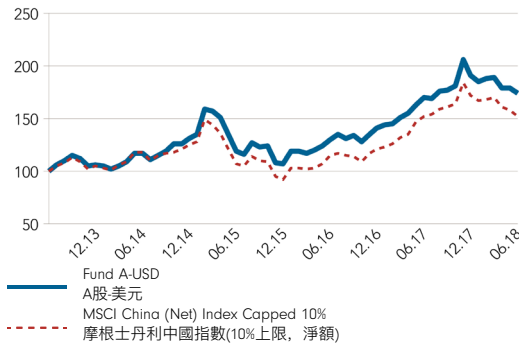
Equity 股票

- This fund invests primarily in Chinese equities securities.
  - The fund is subject to investment, equities, foreign currency, RMB currency risk and risks of investing in emerging markets specific to Hong Kong and the PRC market. The fund's investments are concentrated in Hong Kong and China and the value of the fund may be more volatile. The fund may invest in China A shares directly through the Qualified Foreign Institutional Investor ("QFII") scheme and may incur losses due to limited investment opportunities, illiquidity of the China A shares market, and/or delay or disruption in execution of trades or in settlement of trades. The fund may invest in equity linked notes which may subject to the default risk of the issuer of the note. The fund may invest in certain eligible China A Shares via the Shanghai-HK Stock Connect which may be subject to quota limitations and regulatory risk.

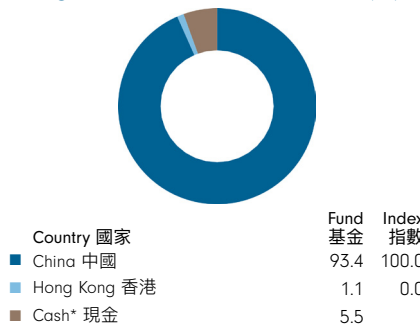

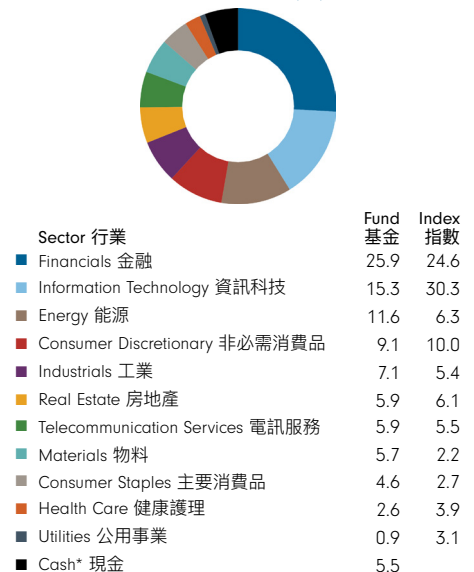
