

# Fidelity Funds – America Fund 富達基金 – 美國基金

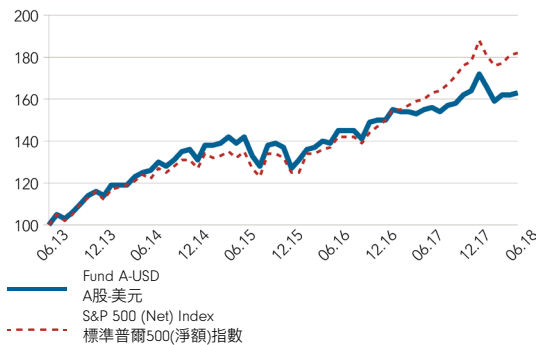

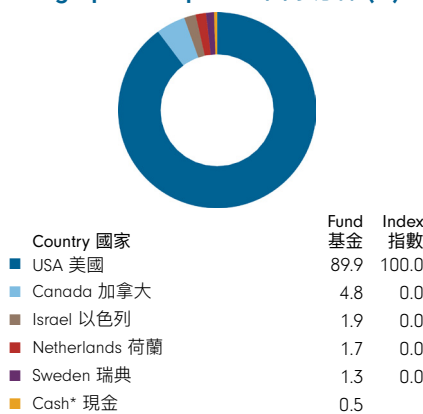

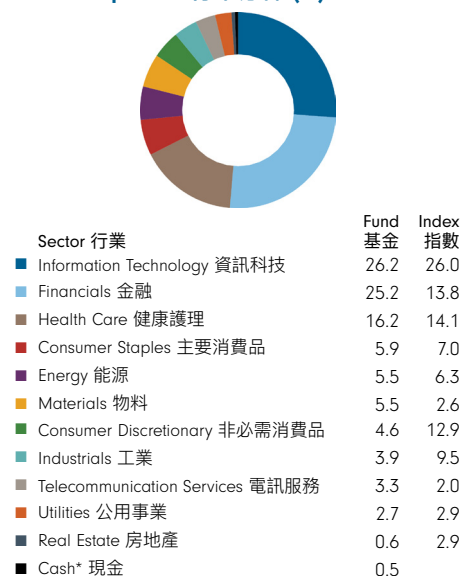
