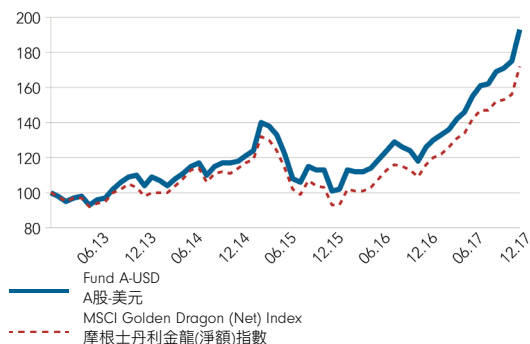
- This fund invests primarily in Greater China equity securities.

The fund may invest in equity linked notes which may be subject to the default risk of the structure of the note. The fund may invest in certain eligible China A Shares via the Shanghai-HK Stock Connect which may be subject to quota limitations and regulatory risk.

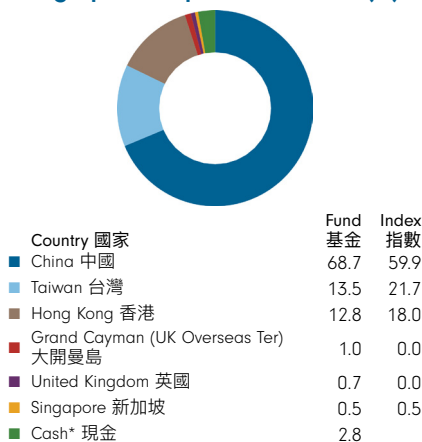

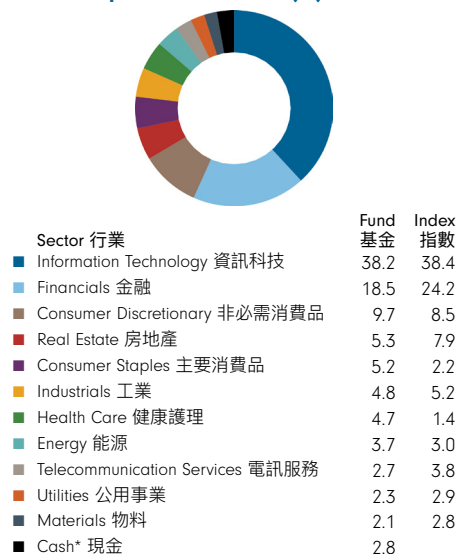
