Fund Commentary[^] 基金評論[^]

Global equities generated positive returns over the quarter. Encouraging corporate earnings and easing trade tensions between the US and Europe supported sentiment. However, US-China trade tensions and concerns around emerging markets led to elevated volatility. Global bonds posted mixed returns, with corporate bonds outperforming government bonds. The US Federal Reserve raised its growth forecasts and increased interest rates as expected. The Bank of Japan introduced greater flexibility to its monetary policy. The Bank of England also increased its key interest rate, while risks of a hard Brexit rose. The fund's exposure to equities was decreased, while the allocation to high-quality bonds was raised over the quarter. Within equities, the allocation to the Asia Pacific and Hong Kong markets was reduced. A strong US dollar could have a significant impact on the Asia Pacific region, especially countries that have borrowed heavily in US dollars. Slowing growth in China could weigh on sentiment towards the Hong Kong market. Meanwhile, the exposure to Japanese and European equities was raised. In Japan, inflation remains weak and the monetary policy is expected to remain loose in the near term. A positive banking lending environment in Japan is also supportive for growth. The European economy remains healthy, but risks such as Brexit and the potential of contagion from Turkey have risen. The exposure to US equities was also raised slightly. Mid-term elections in the US could concern investors in the short term, although the outlook for the US economy remains positive.

環球股市於季內造好。企業盈利令人鼓舞，加上美歐貿易緊張關係緩和，有利投資氣氛。然而，中美貿易爭端和新興市場引發的憂慮，導致市場波幅加劇。環球債券好淡紛呈，企業債券表現優於政府債券。美國聯儲局調高增長預測，並一如市場預期加息。日本央行增加貨幣政策的靈活性。英倫銀行亦上調主要利率，而英國硬脫歐風險上升。基金於季內減持股票，但增持優質債券。股票方面，基金減持亞太區和香港市場的倉盤。美元走強可能對亞太區帶來重大影響，尤其是借入大量美元貸款的國家。中國經濟增長放緩可能導致香港市場投資氣氛受壓。此外，基金增持日本和歐洲股票。日本方面，通脹仍然疲弱，市場預期貨幣政策在短期內保持寬鬆。日本銀行業的借貸環境向好亦有利增長。歐洲經濟仍然穩健，但英國脫歐和土耳其經濟危機可能蔓延的風險升溫。基金亦略為增持美國股票。儘管美國經濟前景仍然向好，但投資者短期內或會憂慮美國中期選舉。
