- (1) 行政管理人及公司秘書由 Brown Brothers Harriman Fund Administration Services (Ireland) Limited 更改為 State Street Fund Services (Ireland) Limited（自 2017 年 7 月 1 日起生效）；
- (2) 存管人由 Brown Brothers Harriman Trustee Services (Ireland) Limited 更改為 State Street Custodial Services (Ireland) Limited（自 2017 年 7 月 1 日起生效）；
- (3) 就證券融資交易作出有關 SFT 規例的新披露（包括有關抵押品的披露的更新）；
- (4) 就傘子現金賬戶的運作作出更新；
- (5) 對有關贖回股份的披露作出更新，即就所有基金而言，本公司有權訂明於任何交易日贖回的任何基金的股份數目須以該基金已發行股份總數的 10% 為限。在這種情況下，本公司將按比例減少於該交易日提出的任何贖回要求，並視贖回要求猶如在各隨後的交易日收到，直至原先要求所涉及的所有股份經已贖回為止。該等修訂乃為反映相關中央銀行 UCITS 規定而作出；

另外，就歐洲議會及理事會日期為 2014 年 5 月 15 日有關金融工具市場及修訂《2002/92/EC 指令》及《2011/61/EU 指令》的《2014/65/EC 指令》（重訂）（即《MiFID II 指令》）作出的更新應予載入（透過對本公司日期為 2018 年 1 月 2 日的基金章程（其後已於 2018 年 2 月 5 日作修訂）作出補充之方式加入）。

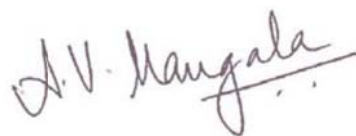

Re: Updates to the Hong Kong Offering Documents of the Company

Dear Shareholder,

We are writing to inform you of the following changes to the Company and the Hong Kong offering documents of the Company:

A. Changes to Minimum Initial Subscription and/or Minimum Holding of the relevant Classes currently offered in Hong Kong

The Minimum Initial Subscription of the Institutional Classes, Class H Institutional Classes, Investor Classes, Administrative Classes, E Classes and M Retail Classes have been changed, with effect from 3 July, 2017, as follows:

B. Other Changes to the Hong Kong Offering Documents

The Hong Kong offering documents of the Company will also be updated, to reflect, amongst other amendments, the following changes made to the Prospectus for the Company dated 3 July, 2017:

- (1) The change of the Administrator and Company Secretary from Brown Brothers Harriman Fund Administration Services (Ireland) Limited to State Street Fund Services (Ireland) Limited (effective from 1 July, 2017);
- (2) The change of the Depositary from Brown Brothers Harriman Trustee Services (Ireland) Limited to State Street Custodial Services (Ireland) Limited (effective from 1 July, 2017);
- (3) New disclosure in relation to the SFT Regulation (including updates to the disclosures on collateral) for Securities Financing Transactions;
- (4) Updates in relation to the operation of the umbrella cash account;
- (5) Updates to the disclosures on redemption of shares that for all Funds the Company is entitled to limit the number of Shares of any Fund redeemed on any Dealing Day to 10% of the total number of Shares of that Fund in issue. In this event, the Company shall reduce pro rata any requests for redemption on that Dealing Day and shall treat the redemption requests as if they were received on each subsequent Dealing Day until all the Shares to which the original request related have been redeemed. Such amendments are made to reflect the relevant Central Bank UCITS requirements;
- (6) Enhanced disclosures, elaboration or clarification on the existing investment policies and risk disclosures of the relevant Funds of the Company in the Hong Kong offering documents of the Company for compliance with the minimum disclosures requirements of the Securities and Futures Commission under the Guide on Practices and Procedures for Application for Authorization of Unit Trusts and Mutual Funds. There is no change to the existing practice; and
- (7) Other miscellaneous and editorial amendments and updates.

Separately, updates in relation to Directive 2014/65/EC of the European Parliament and of the Council of 15 May, 2014 on markets in financial instruments and amending Directive 2002/92/EC and Directive 2011/61/EU (recast), i.e. MiFID II Directive shall be included (which were added by way of a Supplement to the Prospectus for the Company on 2 January, 2018, which has subsequently been amended on 5 February, 2018).

In addition, "Bloomberg" shall be added to the name of the Barclays indices in the Hong Kong offering documents and this shall be reflected in the Prospectus for the Company at the next available opportunity.

C. Update to the Hong Kong Offering Documents of the Company

The Company's Hong Kong offering documents will be updated to reflect the above changes and such updated documents will be available on the Company's Hong Kong website at www.pimco.com.hk in due course. Please note that the contents of the website have not been reviewed by the Securities and Futures Commission.
